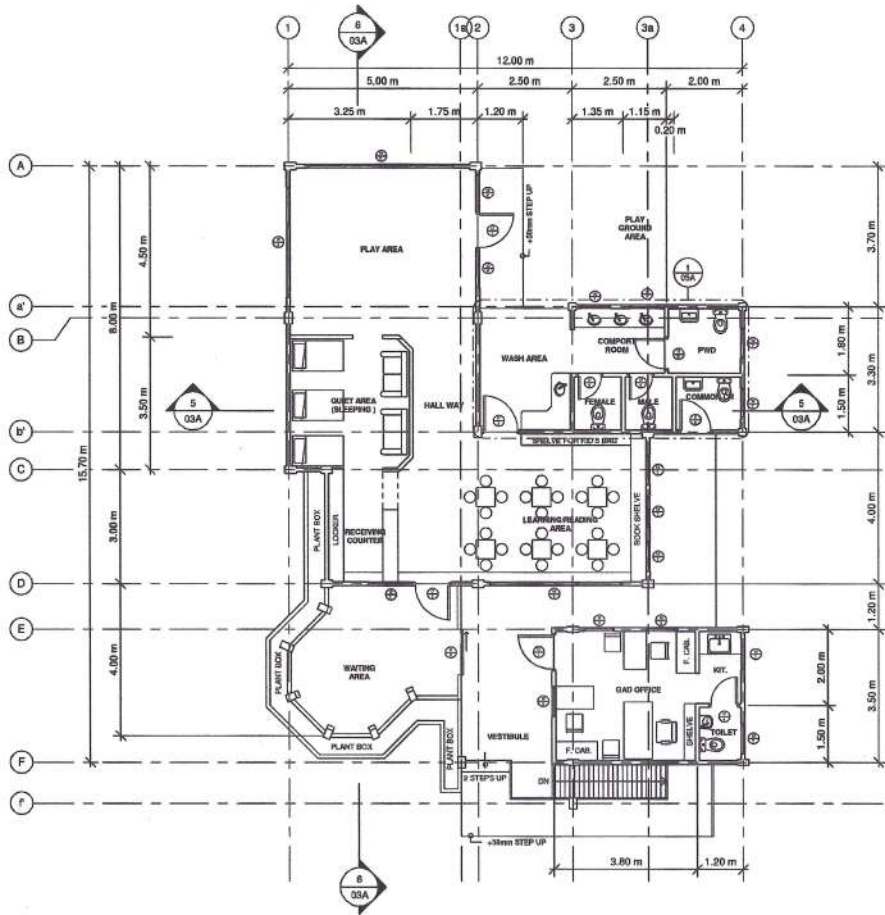
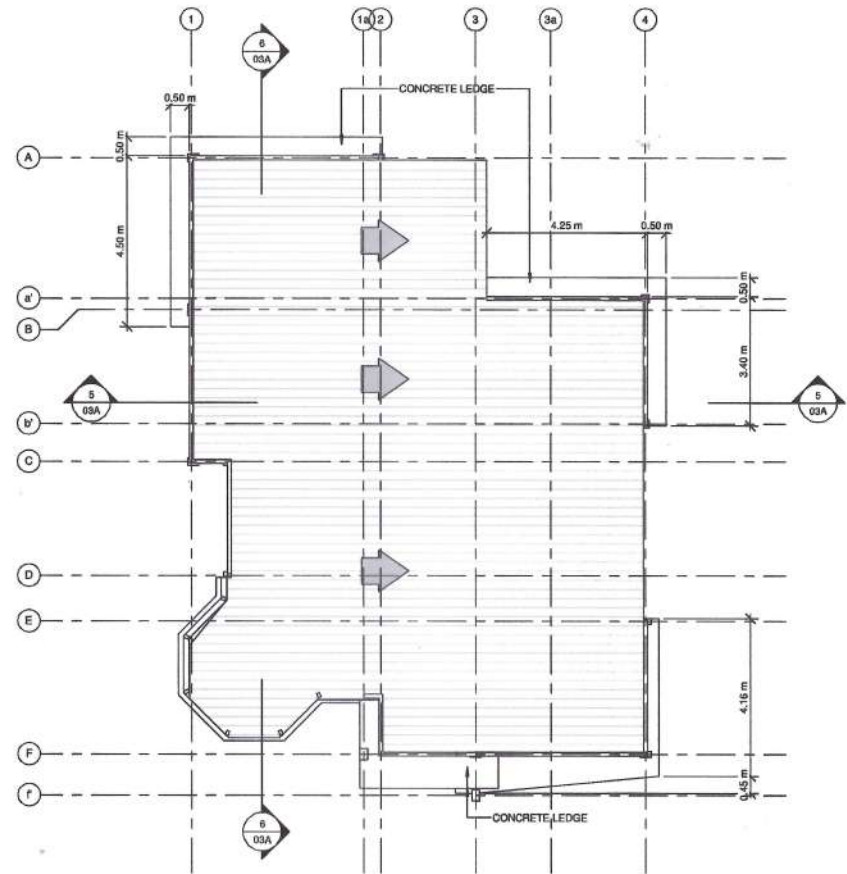

Description: | <p>The RA 111036 or the Philippine Mental Health Act stipulates that educational institutions such as schools, colleges, universities and technical schools and develop policies and programs for students, educators and other employees designed to raise awareness on mental health issues, identify and provide support and services for individual at risk, and facility access, including referral mechanisms of individual with mental health conditions to treatment and psychosocial support. It will also serve as laboratory for the students in Early Childhood Education of the College of Education. The project includes a hall which will serve as a place for learning and playground for toddlers, including equipment and facilities. The Catharsis Corners will be constructed in all colleges of the university. It will be designed to serve as a safe place for the student to express/ release their emotions. The room will be equipped with materials such as stress balls, sketch pad, note pad, pen pencil, coloring materials, safety message box, reading materials, evidence-based self-help brochures, etc. The guidance counselor/guidance associate of each college will monitor the room specifically the message box for further counselling or intervention.</p> | | | | |
